

**Call to Order:**

The re-organization meeting of January 4, 2010 was called to order by Mayor Fox at 8:00 p.m. Answering roll call were Mr. Kissell, Mr. Vandzura, Mr. Slanoc, Mrs. Chobany, Mr. Wozniak, and Ms. McCarthy.

**Nominations to Office:**

Mayor Fox called for nominations of Council President. Mrs. Chobany nominated Ms. McCarthy as Council President. There were no other nominations, nominations closed. Mrs. Chobany motioned, seconded by Mr. Wozniak to appoint Ms. McCarthy as Council President, motion carried 6-0-1 with Ms. McCarthy abstaining.

Ms. McCarthy called for nominations for the Vice President of Council. Mrs. Chobany nominated Mr. Wozniak. There were no other nominations, nominations closed. Mrs. Chobany motioned, seconded by Mr. Slanoc to appoint Mr. Wozniak as Council Vice President, motion carried 6-0-1 with Mr. Wozniak abstaining.

Ms. McCarthy called for appointments to the remaining positions.

Mr. Kissell motioned, seconded by Mrs. Chobany to appoint Mr. Michael Emerick as Borough Solicitor to serve from 2010 through 2011, motion carried 7-0.

Mr. Slanoc motioned, seconded by Mrs. Chobany to appoint Mr. Gary Wisor with Stiffler, McGraw & Associates as Borough Engineer to serve from 2010 through 2011, motion carried.

Mrs. Chobany motioned, seconded by Mr. Kissell to appoint Mr. Charles Pavlosky as the Emergency Management Director from 2010 through 2011, motion carried 7-0.

Mr. Wozniak motioned, seconded by Mr. Slanoc to appoint Mrs. Chobany to serve as the first member of council on the vacancy board, motion carried 6-0-1 with Mrs. Chobany abstaining.

Mrs. Chobany motioned, seconded by Mr. Wozniak to appoint Mr. Slanoc to serve as the seconded member of council on the vacancy board, motion carried 6-0-1 with Mr. Slanoc abstaining.

Mr. Kissell motioned, seconded by Mrs. Chobany to appoint Mr. Matthew Decort to the vacancy board as elector at large, motion carried 7-0.

Mr. Slanoc motioned, seconded by Mr. Wozniak to appoint Mr. Vandzura as the President Pro tempore, motion carried 6-0-1 with Mr. Vandzura abstaining.

Mr. Koban informed Council that the department heads will remain the same with Mr. Ed Miller as Chief of Police for the Public Safety Department; Mr. Don Squillario as Public Works Director; and Ms. Michelle Claar as Borough Secretary.

Mrs. Chobany motioned, seconded by Mr. Wozniak to appoint Mayor Fox as the Borough delegate for the Cambria County Council of Governments, motion carried 6-0-1 with Mayor Fox abstaining.

Mrs. Chobany motioned, seconded by Mr. Wozniak to designate First Summit Bank as the financial depository for the Borough General Fund, Tax Clearing, and State Liquid Fuels Accounts, motion carried 7-0.

Mrs. Chobany motioned, seconded by Mayor Fox to designate the Dispatch as the first and the Tribune Democrat as the second for the newspaper of general circulation of official legal notices and advertisements, motion carried 7-0.

**New Business:**

The US Census Bureau submitted a request and an agreement to utilize Council Chambers by donating space for the 2010 census for a Questionnaire Assistance Center for a period of four (4) weeks commencing March 19, 2010 through April 19, 2010. Mr. Kissell motioned, seconded by Mr. Slanoc to approve the donation of space agreement with the US Census Bureau to utilize Council Chambers for a period of four (4) weeks commencing 3/19/10 through 4/19/10, motion carried 7-0.

Ms. McCarthy commented that she appreciates everyone working together for the community and looks forward to another year.
